- I. The technical and financial proposals should be submitted in triplicate. Being one (1) original. And two ( 2 ) identical copies in format and content;
- II. All foreign tenderers must meet also the requirements established in Article 27 of Decree 15/2010, May 24, as follows:
  - a. Must comply with the general norms established in this Regulation, in specific legislation and in the Tender Documents, by submitting documents equivalent to those required from national tenderers.
  - b. Foreign tenderers, whether or not authorized to perform their activities in Mozambique, must furthermore:
    - i. Have an agent resident and domiciled in the Country, with special powers to be served with process, to receive notices and to respond administratively and judicially for the tenderer's acts, submitting the power of attorney with the documents listed in this Regulation;
    - ii. Prove their legal, economic, financial and technical qualification and their good fiscal standing in their country of origin;
    - iii. Prove the inexistence of bankruptcy or judicial reorganization requests in Mozambique and in the country of origin; and
    - iv. Submit documents written in the Portuguese language.
  - c. Mozambique Revenue Authority may, whenever it deems it necessary, confirm the veracity of the contents of the documents referred to in items b) and c) of the previous number.
